Message from our President

I am writing you on the fabulous weather weekend of May 3rd. It was such a treat after the winter we left behind. In early April there was 25 inches of ice on our lake. The ice was gone by Tuesday April 28.

Please note that we have changed the AGM date from the long weekend to the weekend after the long weekend and changed to Sunday morning with the hopes that we will get an improved attendance.

We again face an issue coming at us from local government. Peter Shoemaker has attended meetings on our behalf with other members of this lake community. I can't stress how valuable it is to us all to have individuals dedicate their time and skills to attending Council meetings at Hastings Highlands. It continues to be essential to attend these meetings to stay informed as the Hastings Highlands web-site does not disclose any detailed agendas.



We had great support from the membership on Septage. Now it is over, but the challenges are not. This association is successful with strong participation. The membership committee of Mary Mueller & Susan Bateman were very successful last year & are already active this year. We expect to have area rep packages available for the holiday weekend in May. If you want to meet your fellow lakefront owners contact Mary and become an area rep. She will make an opportunity for you.

This survey will be used at the AGM to decide how to utilize these funds.

We need volunteers to keep this organization delivering the value that you expect. We need someone with reasonable skills to be our new Treasurer. To date no one has stepped up to meet this need. We know someone is out there and we need you.

Similarly we have asked for volunteers to step up and help plan the regatta. We believe a large component of the lake front highly values this event. To date no one has come forward. You will not be alone; if a number step up the work is small.

We are seeing members strengthen our water quality testing by attending training. This training was provided by The Coalition of Haliburton Property Owners' Associations (COHPOA) . We have a volunteer to lead the raffle that generates moneys that are used to support the medical facilities in our area. She will be looking for help in this area.

Vice President's Message:

Hastings Highlands has undertaken to modify the Comprehensive Zoning By-Law with definitions for the Vegetative Buffer surrounding lakes and rivers, Access Corridors through the vegetative buffer and Shoreline Activity Areas, the area adjacent to the water . They have also spelled out in detail penalties for violating the zoning By-Law. To date two meetings have been held with members of Council, Hastings Highlands' staff, representatives of the various lake associations and members of the public. At the council meeting on May 6th Staff included proposed revisions to the original by-law, these have not yet been adopted by Council. These changes address some of the shortcomings of the original. These revisions have been included in the Annotated By-Law.



Hastings Highlands has scheduled a public meeting on May 23rd at 9:00 am at the town offices in Maynooth to review the proposed changes. A public meeting is necessary in advance of modifying the Zoning By-Law.

A proper vegetative buffer is important in the maintenance of a healthy lake. It traps run off and prevents it from going into the lake, the root systems filter out phosphates and other nutrients, it provides habitat for birds and animals and by shading the water helps to cool the lake.

At the same time it is important that the By-Law allow the enjoyment of our properties and recognize that in general, property owners act as wise stewards of their land and have a keen interest in preserving the integrity of their lake.

If you are present at the lake on the weekend of May 23rd, try to attend the session, it is your opportunity to express your views on the subject. In the Public Notice from the municipality it is stated that if you do not attend or make a written presentation to Hastings Highlands you will not be entitled to make an appeal to the Ontario Municipal Board regarding the amendments to the Comprehensive Zoning By-Law.

As a reminder, roadside pickup of waste and recycling has been discontinued as of January 1st 2015. Summer Dump Site hours have not yet been announced, Winter hours (until May long weekend) for the Papineau Lake dump site are Thursday, Saturday and Sunday from 12:00 to 5:00 pm.

Treasurer's Report

The PLCA had another strong year financially. The 2014 financial statements have been prepared for filing and we are ready for 2015. We continue to encourage as many as can to pay your membership dues utilizing the ETRANSFER of your payments directly through your bank account. We can now accept payments when you ETRANSFER your \$25 membership dues to Steve.Smith@Papineaulake.com. When you log into to your bank site, look for the Interac ETransfer tab and follow the instructions. Keep the security question simple and the answer being a certain lake we go to. (single word, lower case) In the comments section, please include the cottage owner and address so we can cross check the payment and it's done. We do have new annual tags to be placed on your PLCA driveway signs showing you are a member for 2015 and have paid your dues so we'll make arrangements to get the 2015 tag to you.

Full details of our financial statements will be discussed at the AGM on the July long weekend.

Septage Account

A full statement of the Septage account for 2014 will be presented at the 2015 AGM. Once the refunds were returned and we accounted for the prepaid memberships, the remaining funds totalling, some \$6500 will be transferred to the general account.

Lake Steward Report

Lake water quality continues to be monitored on a regular basis, both through our participation in the Ministry of Environment and Climate Change (MOECC) Lake Partner Program and through our own sample collection and analysis. Through the Lake Partner program we record water clarity readings with a Secchi disk and send samples to the MOECC to test for Total Phosphorus concentrations. The PLCA has also been testing for E.coli and for nitrogen in the forms of nitrate and nitrite. Papineau Lake has historically measured low in phosphorus and nitrogen concentrations which should guard against nuisance algal blooms that other lakes in the province have been experiencing.



Over the past year we have had multiple opportunities to network with Lake Stewards and property owners from other area lakes to share experiences, learn what issues other lakes are concerned with and what stewardship actions they are taking. The development landscape differs from region to region or even lake to lake. Some lakes have large towns, waste water treatment plants, farms, and a higher percentage of manicured lawns in the immediate shoreline areas. While the root causes of ecosystem stress may differ from lake to lake, we are united in our concern for the impacts our activities are having on our lakes and for what stewardship actions we can take to protect our lakes for the enjoyment of future generations.

In July of last year we attended a hands-on Shoreline Restoration Workshop hosted by the Environment Council for Clear, Stoney and White Lakes. This workshop provided information on:

- * Repairing shoreline damage from spring flooding;
- * Preventing erosion from waves and boat wakes;
- * Enhancing wildlife habitat;
- * Identifying and removing invasive plants;
- * Planting native shoreline species;
- * Building wildlife habitat structures.

We have also attended a number of events hosted by the Coalition of Haliburton Property Owners Associations, the most recent being a Lake Stewards Water Quality Testing Training Session where information was provided on blue green algae, Lake Partner Program Testing, invasive species, dissolved oxygen testing and benthic testing.

In addition to water quality testing, our focus this year will be on shoreline stewardship and how this relates to the municipality's proposed vegetative buffer by-law. We invite you to attend our Annual General Meeting where we will be showing short but informative videos on shoreline stewardship. We are also putting together an "Environmental Working Group" for anyone interested in getting involved with or learning more about water testing or stewardship/environmental initiatives. 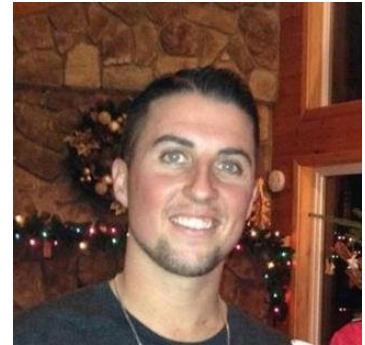



**NOTICE OF A PUBLIC MEETING
CONCERNING PROPOSED ZONING BY-LAW AMENDMENT**

TAKE NOTICE, that the Council of the Municipality of Hastings Highlands proposes a Zoning By-Law Amendment according to Section 34. (10) of the Planning Act.

AND that the Council of the Municipality of Hastings Highlands will hold a public meeting on Saturday, May 23rd, 2015 at 9:00 a.m. at the Hastings Highlands Centre, 33011 Highway 62, Maynooth, Ontario, to consider a proposed zoning by-law amendment under Section 34 of the Planning Act.

The proposed zoning by-law amendment is to include the addition of DEFINITIONS for the following:

- "VEGETATIVE BUFFER"
- "ACCESS CORRIDOR"
- "SHORELINE ACTIVITY AREA"

And amending Section 4.5 "VIOLATIONS AND PENALTIES" of Comprehensive Zoning By-Law 2004-035.

ANY PERSON may attend the public meeting and/or make written or verbal representation either for or against the proposed amendment. Written submission should be directed to Building/Planning Clerk at the address below.

IF a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Hastings Highlands before the by-law is passed, the person or public body is not entitled to appeal the decision of the Municipality of Hastings Highlands to the Ontario Municipal Board

IF a person or public body does not make oral submissions at a public meeting or make written submissions to the Municipality of Hastings Highlands before the proposed zoning amendment is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

IF YOU WISH TO BE NOTIFIED of the passing of the proposed Zoning Amendment, or of the refusal of a request to amend the Zoning By-Law, you must make written request to the address at the bottom of this page.

ADDITIONAL INFORMATION relating to the proposed amendment is available for inspection at the office of the undersigned.
